Status of ARF Decisions (1994-2018)

Executive Summary

- The ARF Ministers at their 11th Meeting in July 2004 agreed that the Matrix on ARF Decisions and their Status be updated on an annual basis to build institutional memory and compile an official annual record of implementation. This Executive Summary is an update on ARF decisions and their implementation in the intersessional year 2017-2018.
- 2. Following the completion of the previous cycle, the 10th ARF Inter-Sessional Meeting on Maritime Security (ISM on MS), co-chaired by Viet Nam, Australia and the European Union, was held in March 2018. The Meeting deliberated on the draft Work Plan on Maritime Security 2018-2020 which has been updated to reflect the current development and recent trends in maritime security. The Work Plan will be submitted for ARF Ministers' adoption at the 25th ARF.
- 3. The 17th ARF Inter-Sessional Meeting on Disaster Relief, (ISM on DR) co-chaired by Thailand and Republic of Korea (ROK) in April 2018 took note that the activities under the ARF Work Plan on Disaster Relief 2015-2017 were in line with the ASEAN Agreement on Disaster Management and Emergency Response (AADMER) Work Programme 2016-2020 and ASEAN Vision 2025 on Disaster Management. The Work Plan on Disaster Relief 2018-2020 will be submitted to the 25th ARF for adoption.
- 4. The 10th ARF Inter-Sessional Meeting on Non-Proliferation and Disarmament (ISM on NPD), co-chaired by Indonesia, Japan and ROK, was held in April 2018. The Meeting noted that the ARF Work Plan on NPD is a living document which is to be updated as deemed necessary, and deliberated on the inputs received by ARF Participants.
- 5. Following the adoption of the Concept Paper on the Establishment of the ARF Inter-Sessional Meeting on Security of and in the Use of Information and Communication Technologies (ISM on ICTs Security) by the 24th ARF in 2017, the inaugural ISM on ICTs Security was convened in Kuala Lumpur in April 2018. The Meeting was preceded by two Open Ended Study Groups to Reduce the Risk of Conflict Stemming from the Use of Information and Communication Technologies which were held in Tokyo in January 2018 and in Kuala Lumpur in April 2018. The Meeting discussed proposed initiatives on ICTs Security and the Terms of Reference (TOR) of the Study Group, as well as proposed priority areas to be incorporated into the ARF Work Plan on ICTs Security.
- 6. The ARF Defence Officials' Dialogue (DOD) was held back-to-back with the ARF ISG on CBMs and PD in May 2018 and the 15^h ARF Security Policy Conference (ASPC) was held in June 2018. On the proposal to streamline and synergise the ARF DOD and the ASPC, both Meetings agreed that a status quo on the proposal shall be maintained.
- 7. The 12th ARF Experts and Eminent Persons Meeting formulated recommendations for the consideration of the ARF, including the establishment of

- an EEPs working group to review and compile all preventive diplomacy activities that have been implemented under the ARF framework.
- 8. The ARF Inter-Sessional Support Group Meeting on Confidence-Building Measures and Preventive Diplomacy (ISG on CBMs and PD) in Auckland in May 2018 reviewed the current and future implementation of PD activities under the ARF Work Plan on Preventive Diplomacy.
- 9. The ARF Senior Officials' Meeting in June 2018 noted the current status of the ARF Fund and agreed that the ARF Fund shall be retained for funding of future ARF activities and projects.
