## The output of the workshop: the Guangzhou Statement on Ferry Safety

- The Crucial role of Domestic ferry operation
- The Safety of domestic ferries is a shared responsibility between and among Governments; shipowners, ship managers, ship-operators; shipboard personnel; maritime education and training institutions; classification societies; and the public and civil society as user of the services provided
- Encouraging to develop an appropriate, coherent and fit for purpose regulations
- Encouraging to develop and implement a safety management system
- suggests the organization of a correspondence group on domestic ferry safety for purposes of conducting regional forum, sharing of information & best practices

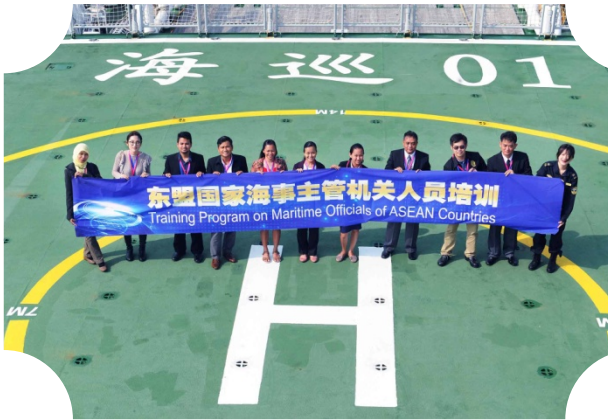

# B2-Regional training for Maritime Authority staffs

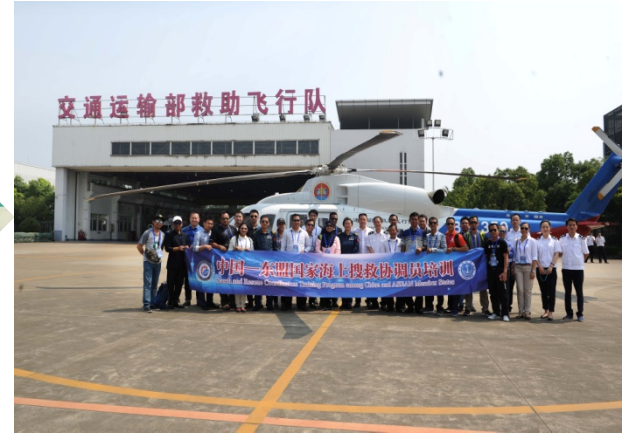

# B5-MTCC-Asia First Regional workshop

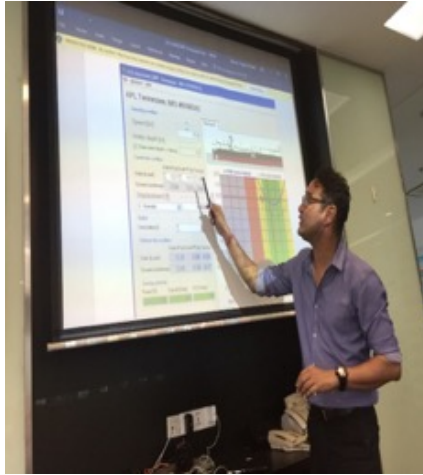


- Organized by MTCC Asia
