## CSCAP Memorandum on "Safety and Security of Vital Undersea Communications Infrastructure" proposes specific measures on:

- Actions by States

- All states should join the International Cable Protection Committee (ICPC).
- Each State should designate a national lead agency for submarine cable issues.

- Regional Cooperation

- Once designated, national lead agencies of states should coordinate (with industry/ICPC and other states) to: (i) Develop regional protocols to facilitate prompt cable repairs, and (ii) Develop standard procedures for both information sharing and to notify other regional nations of cable breaks or suspicious activity.
- Include tabletop exercises to deal with cable breaks and threats to cables in regional multilateral and bilateral exercises.

# CSCAP Memorandum on "Maritime CBMs, Trust & Managing Incidents at Sea" specific crisis prevention and management measures:

- ASEAN and dialogue partners should continue to work on moving from CBMs to preventive diplomacy

- ASEAN states and China should steadily advance consultation on a Code of Conduct in the South China Sea within the framework of a complete and effective implementation of the Declaration of the Conduct (DOC) of Parties issued in 2002, and adhere to the 2011 Guidelines for the Implementation of the DOC

- Need for a center to coordinate and promote maritime situational awareness throughout the region

- At the operational level, Memo highlights value of functional cooperation (e.g., SAR, HADR), Code for Unalerted Encounters at Sea (CUES), and a region wide forum for coast guards

#### UNCLOS and Preservation of Marine Environment: CSCAP Memoranda Highlights

- No. 4 and No. 5: Highlight need for maritime cooperation in preservation of marine environment
- No. 6: Briefly summarizes regional perspectives and areas of agreement and differences regarding UNCLOS, but little mention of marine environment issues
- No. 8: For security of seaborne trade, advocates a coordinated regional maritime monitoring system to support regional responses, including marine environment protection
- *No. 12:* In addressing maritime knowledge awareness needs, highlights that all CSCAP states have signed IMO Pollution Convention (MARPOL 73/78)
- No. 13: Highlights UNCLOS Art. 123 responsibilities, that states bordering enclosed and semi-enclosed seas "should cooperate...and shall endeavor, directly or through an appropriate regional organization...to coordinate the implementation of their rights and duties with respect to the protection and preservation of the marine environment." Advocates littoral states to "consult regarding cooperation in taking all measures necessary to prevent, reduce, monitor and control pollution," to ratify and implement all relevant conventions, and to develop contingency plans to respond to marine pollution threats
- No. 16: Regarding offshore oil and gas installations, highlights potential for major environmental disaster, marine pollution, and advocates cooperation in risk mitigation, regional response measures, and government-industry partnerships

### UNCLOS and Dispute Settlement: CSCAP Memoranda Highlights

- No. 4: Comprehensive guidelines as principles for regional maritime cooperation. Encourages all states to become parties to UNCLOS. Encourages states to homogenize procedures IAW UNCLOS Art. XIII for granting consent to Marine Scientific Research in EEZs
- No. 5: Best practices for cooperation to maintain law and order at sea. Outlines different UNCLOS zones of maritime jurisdiction, Urges flag states to respect rights under UNCLOS. Advocates a Protocol on EEZ jurisdiction. Discusses maritime enforcement and information in context of UNCLOS.
