ASEAN Regional Forum (ARF) Workshop on National Maritime Single Points of Contact 28-29 April 2016

Objectives and Provisional Agenda

The Philippine's National Coast Watch Council Secretariat, Australian Border Force, and US Pacific Command, will be co-hosting the ASEAN Regional Forum (ARF) Workshop of National Maritime Single Points of Contact on April 2016 at Cebu City ,Philippines. This activity is part of the ARF Maritime Security Work Program for the intersessional year 2015-2017.

The event shall feature facilitated discussions that focus on identifying opportunities for enhancement of maritime security within the region through functional cooperation among the national maritime single points of contact.

- A. Objectives. The Workshop shall have the following objectives:
 - 1. Promote transparency through the sharing of national best practices and experiences on developing ways and means of addressing maritime security concerns. This shall involve briefings on the national-level experiences in the establishment of either a coordinating body or a directing agency for maritime security operations. This sharing of best practices may provide insights to other countries still in the process of developing national maritime single points of contacts on how to manage the challenges in moving forward with such initiative.
 - 2. Establish working level interaction among the personnel of the region's national maritime single points of contact. As a working level meeting, the participants for the workshop should be senior operational level officers who has policy knowledge and working experience on how their organizations accomplish their tasks. The working level interaction shall focus on how existing organizations within each nation can coordinate and cooperate with their counterparts. The essential requirements for such cross-country coordination will be identified and discussed.
 - 3. Discuss and identify the elements of a future framework of cooperation on maritime security including protocols on information sharing and coordinated response consistent with international law and existing multilateral agreements. This objective is aimed at identifying the essential characteristics and capabilities of a national maritime single points of contact and the requisites for establishing cooperative activities among them.
 - 4. Identify specific activities that provide mutual support in developing capabilities and capacities of national maritime single points of contact for cross-border and multilateral maritime security

operations. The aim of the workshop is to identify concrete and incremental steps to realize the goal of a shared domain awareness within the region.

B. Participants. The quality of participants is critical to the success of the event. Following the principle of ASEAN Centrality in the work of the ARF, all ten (10) ASEAN nations' must be represented in the Workshop. Recognizing the inherent differences in the structures and authorities of existing national organizations, it is necessary to identify the focus areas of the discussion. This will allow the member States of ARF to identify among the national points of contact who should be represented during the discussions.

The maritime concerns in the region can either be safety, law enforcement, and economic security issues. Safety issues are addressed by already established procedures and organizations. They operate and coordinate mainly through established Search and Rescue Coordinating Centers. The greater gap in capabilities, capacities, and coordination are found among law enforcement and economic security organizations.

Further recognizing the differences in the mandates, organizational structures, and capabilities of national maritime law enforcement agencies in the region, each national government must identify the most appropriate entities to participate in the workshop. To provide a level of commonality, the delegation should come from or composed of representatives from organizations having a combination of any of the following characteristis:

- a. It is manning and maintaining a 24/7 operational center;
- b. It vested with the authority to either coordinate or direct inter-agency actions on law enforcement;
- c. It is equipped with mission essential communications systems to maintain a common operating picture; and
- d. Being a law enforcement organization, the required participating agency or coordinating body must have the ability to provide basic operational legal advice.
