1330-1345 **Session Introduction:** ASEAN's ongoing disaster preparedness and response activities operate in the context of the ASEAN Agreement on Disaster Management and Emergency Response (AADMER), for which a work plan was recently generated to cover 2016-2020. Concurrently, other global frameworks have been updated to more fully recognize and integrate climate change elements as relevant to disaster management, such as the UN's 2015 Sendai Framework for Disaster Risk Reduction, and the UN's Transforming our world: the 2030 Agenda for Sustainable Development (a.k.a. Sustainable Development Goals, or SDGs).

> Meanwhile the UN's World Humanitarian Summit is working to establish global standards for humanitarian assistance, which likewise has implications for AADMER. Finally, there are important new initiatives emerging regionally within the private sector that have the potential to enhance and augment both national and regional efforts on DRM and climate resilience. This session will look at these developments and their potential implications for AADMER.
