### 11:30 Session V: **Panel discussion and Q&A's: Lessons learned and opportunities and challenges for joint future action**

*In the previous four sessions, CVE/PVE have been discussed from different angles; prevention of violent extremism and radicalisation, prison deradicalisation, the different policy options for CVE/PVE, the phenomenon of online radicalisation and the development of a counter narrative as a response to this threat have all been extensively discussed. This final session will look at CVE/PVE from a security perspective – with the phenomenon of foreign fighter returnees determined as the main driver of the current terrorist threat in both the EU and the ARF region with the expected demise of ISIL/Da'esh, a proper security response to CVE/PVE should be a priority. The discussions should focus on the challenge of combining the 'soft' approach to CVE/PVE (such as prevention projects, deradicalisation efforts in prisons) with the 'hard' approach (the involvement of the police and intelligence & security services). The results of the panel discussion can be used as input for the evaluation of the ARF CTTC Work Plan 2015-2017, which is up for review this year. The adoption of a joint declaration on CVE/PVE will serve as the formal conclusion to the workshop.*
